**Monitoring and Review:**

- This policy will be subject to continuous monitoring, refinement and audit by the Headmistress.
- It is intended that the review and development of the curriculum will support enthusiastic and inspirational teaching. The process of review plays a key role in the continuing professional development of the teaching staff at Orchard School.
- The Deputy Head monitors the way in which subjects are taught throughout the school. She examines long-term and medium-term planning, and ensures that appropriate teaching strategies are used. The Deputy Head also has responsibility for monitoring the way in which resources are stored and managed.
- The Senior Management Team is responsible for monitoring the way in which the school curriculum is implemented. The team reviews each subject area during its cycle of review and development.
- The Head of Academic Studies is responsible for the day-to-day organisation of the curriculum. She monitors the weekly lesson plans for all teachers, ensuring that all classes are taught the full requirements of the School Curriculum, and that all lessons have appropriate learning intentions, addressing the needs of all pupils.
- The Proprietor (who is also the Headmistress) undertakes an annual review of this policy and of the efficiency with which the related duties have been discharged, by no later than one year from the date shown below, or earlier if changes in legislation, regulatory requirements or best practice guidelines so require.

## Introduction

Our school's curriculum comprises all the planned activities that we organise in order to promote pupils' learning, and their personal and social development. It includes not only the formal requirements of the National Curriculum, but also the various out of school hours activities that the school organises in order to enrich the children's experience. It also includes what is sometimes referred to as the 'hidden curriculum' – what the children learn from the general climate and culture of our school, and the way they are treated and expected to behave. We want children to grow into positive, responsible people, who can work and co-operate with others while at the same time developing their knowledge and skills, in order to achieve their full potential.

We ensure that the teaching at Orchard School:

- enables pupils to acquire new knowledge and make progress according to their ability so that they increase their understanding and develop their skills in the subjects taught;
- fosters in pupils the application of intellectual, physical or creative effort, interest in their work and the ability to think and learn for themselves;
- involves well planned lessons and effective teaching methods, activities and management of class time;
- shows a good understanding of the aptitudes, needs and prior attainments of the pupils, and ensures that these are taken into account in the planning of lessons;
- demonstrates appropriate knowledge and understanding of the subject matter being taught;
- utilises effectively classroom resources of an adequate quality, quantity and range;
- demonstrates that a framework is in place to assess pupils' work regularly and thoroughly and use information from that assessment to plan teaching so that pupils can progress and
- utilises effective strategies for managing behaviour and encourages pupils to act responsibly.

We value the breadth and range of our curriculum. We aim to foster creativity in our children, and to help them become independent learners. The Proprietor of Orchard School ensures that the school has a framework for pupil performance to be evaluated, by reference both to the school's own aims as provided to parents and also to national norms. Above all, we believe in making learning fun. Orchard School ensures that the curriculum gives all pupils experience in linguistic, mathematical, scientific, technological, human and social, physical and aesthetic and creative education.

*Linguistic* (including English and French): This area is concerned with developing pupils' communication skills and increasing their command of language through listening, speaking, reading and writing. French is taught from the Nursery onwards, by a specialist teacher.

*Mathematical* This area helps pupils to make measurements and calculations, to understand and appreciate relationships and patterns in number and space and to develop their capacity to think logically and express themselves clearly. Their knowledge and understanding of mathematics is to be developed in a variety of ways, including practical activity, exploration and discussion.

*Scientific* (including General Science which covers aspects of biology, chemistry and physics): This area is concerned with increasing pupils' knowledge and understanding of nature, materials and forces and with developing the skills associated with science as a process of enquiry: for example, observing, forming hypotheses, conducting experiments and recording and interpreting their findings.

*Technological* (including Art, Design and ICT): Technological skills can include information and communication technology (ICT); developing, planning and communicating ideas; working with tools, equipment, materials and components to produce products which the pupils are proud of and evaluating processes and products.

*Human and Social* (including Geography, History, Ethics, and Philosophy, Politics and Religious Studies at a level appropriate to the child's development): This area is concerned with people and with their environment, and how human action, now and in the past, has influenced events and conditions. In our school, the subjects of history and geography make a strong contribution to this area.

*Physical* (including PE, Dance, swimming and an extensive extra-curricular programme): This area aims to develop the pupils' physical control and co-ordination as well as their tactical skills and imaginative responses, and to help them to evaluate and improve their performance. Pupils should also acquire knowledge and understanding of the basic principles of fitness and health. Specialists teach PE and Dance for the whole school from Nursery and there are a variety of clubs offered both by external agencies and by internal teaching staff.

*Aesthetic and creative* (including Art, Drama and Music): This area is concerned with the processes of making, composing and inventing. There are aesthetic and creating aspects of all subjects, but some make a particularly strong contribution, including ICT and the study of literature, because they call for personal, imaginative, and often practical, responses. Music is taught by a specialist teacher. Opportunities for visits from Drama groups and external agencies are planned as appropriate. Pupils are encouraged to demonstrate their learning in a variety of ways. We have regular musical/drama events throughout the year, including, School Productions, Remembrance, Christmas Carol Service and Nativity Play, Easter Service and an Informal Music Concerts.

### **Aims and objectives**

The aims of our school curriculum are:

- to enable all children to learn and develop their skills to the best of their ability;
- to promote a positive attitude towards learning, so that children enjoy coming to school, and acquire a solid basis for lifelong learning;
- to teach children the basic skills of literacy and numeracy;
- to enable children to be innovative, to use 'thinking' and problem solving skills, and to be independent learners;
- to develop children's skills of team work and the ability to work in collaboration with others;
- to enable children to understand and appreciate the arts, and give them opportunities to develop their own artistic and creative abilities;
- to teach children about the developing world, including how their environment and society have changed over time;
- to help children understand Britain's cultural heritage;
- to enable children to appreciate and understand the importance of scientific and technological discoveries and development;
- to give children an awareness and experience of communicating in languages other than English;
- to teach children ICT skills and to apply these skills across the curriculum to support their learning;
- to appreciate and value the contribution made by all ethnic groups in our multi-cultural society;
- to enable children to be positive citizens, contributing to the society in which they live;
- to teach children to have an awareness of their own spiritual development, and to distinguish right from wrong from an early age;
- to help children understand the importance of truth and fairness, so that they grow up committed to equal opportunities for all;
- to enable children to have respect for themselves and high self-esteem, and to live and work co-operatively with others.

### **Auditing our curriculum: teaching and learning**

We ask ourselves the following questions when auditing our current performance:

- How well are we doing?
- How do we compare with similar schools?
- What more should we aim to achieve?
- What must we do to make it happen?

When evaluating the quality of the curriculum, we consider:

- the impact of the curriculum on pupils' academic and personal development and in preparing them for the opportunities, choices, responsibilities and experiences of adult life;
- the contribution of the curriculum to the school's particular ethos and aims and the impact on pupils' academic and personal development and well-being;

- how well curriculum planning is supported by appropriate schemes of work, builds systematically upon pupils' prior experience and plans for progression;
- the extent to which the curriculum is enriched by extra-curricular opportunities and through collaboration with other schools and organisations;
- the views of our pupils, parents and staff;

### **Standards of attainment**

We carry out data analysis each year and use the data provided to find out how well pupils in our school are achieving, compared with pupils in similar schools. We analyse the statistics to help answer the following questions:

- Do pupils perform better in some subjects than others?
- Are there significant differences between boys' and girls' performances?
- How well are the more able pupils doing, and do enough pupils achieve the higher levels?
- Can we identify any groups of pupils who may be underperforming?
- Can we identify any groups of pupils who may be doing well?
- How do expectations and estimates compare with final results?

### **The Learning Environment**

We believe that a purposeful and structured learning environment is essential in promoting high standards. A positive caring environment and culture will promote positive self-esteem and confidence. Organised resources, displays of pupil's work, stimulating materials and bright, colourful language along with interactive displays all help to provide the optimal learning environment. We ensure that all tasks and activities that the pupils perform and the environment in which they learn are safe. When we plan to take pupils out of school, we follow a strict set of procedures to ensure safety: where applicable the venue is visited, risk assessments are completed, and various permissions are obtained. Parents/guardians are informed, and their permission obtained before the visit takes place. Appropriate adult to pupil ratios are maintained according to the children's ages.

Teaching assistants and other adult helpers are deployed as effectively as possible. Sometimes they work with individual pupils and sometimes they work with small groups. Our school is an attractive learning environment. We ensure that all pupils have the opportunity to display their best work at some time during the year. We believe that a stimulating environment sets the climate for learning, and an exciting classroom promotes independent use of resources and high-quality work by the pupils. All our teachers reflect on their strengths and weaknesses and plan their professional development needs accordingly. We do all we can to support our teachers in developing their skills, so that they can continually improve their practice. We conduct all our teaching in an atmosphere of trust and respect for all.

### **Effective learning**

We acknowledge that people learn in many different ways, and respond best to different types of input (visual, auditory and kinaesthetic); we must therefore deliver teaching in different ways to address the needs of all our learners. We ensure the best possible environment for learning by developing a positive atmosphere in which pupils feel safe and feel they belong, in which they enjoy being challenged, but in which they enjoy learning, and know that they will succeed (because they know the challenge will have been set at the right level). Our pupils are encouraged to develop a resilient and positive attitude to experimentation and competition, understanding that 'mistakes' are an opportunity for learning; they understand the importance of trying their best and learn to recognise and celebrate their own achievements and progress. All teaching is structured to maximise learning opportunities and lessons are planned in accordance with the following principles:

- The teaching should build on previous learning.
- It should give pupils the 'big picture' of the lesson and where it fits in their wider learning.
- The teacher should explain the learning objectives, and why the lesson is important.
- Our accepted procedure is the inclusion of learning objectives both in lesson planning and also as statements in the children's workbooks.
- The lesson should be presented in a range of styles.
- It should allow opportunities for the pupils to build up their own understanding through various activities.
- It should allow opportunities for the pupils to review what has been learnt.

- It should have built-in opportunities for feedback to the pupils, celebrating success and reviewing learning strategies.
- The teaching should indicate what the next step in the learning will be.

We offer opportunities for pupils to learn in different ways. These include:

- Investigation, practical tasks and problem solving;
- applying knowledge gained to create something new;
- research and finding out;
- group work;
- pair work;
- independent work;
- whole-class work;
- asking and answering questions;
- use of ICT;
- fieldwork and visits to places of educational interest;
- the use of guest speakers and parents talking about current events, cultural or religious celebrations and their careers or interests
- watching television, film and responding to musical or tape-recorded material;
- debates, role-plays and oral presentations (we have an annual poetry competition for pupils in KS1 and 2;

We encourage pupils to take responsibility for their own learning, to be involved as far as possible in reviewing the way they learn, and to reflect on how they learn – what helps them learn and what makes it difficult for them to learn. Assessment and marking are an integral part of the teaching and learning process. As outlined in the Assessment and Marking Policy, informal formative assessment (Assessment for Learning or AfL) takes place continuously in the classroom and comprises of:

- effective teacher questioning;
- observations of learning;
- analysing and interpreting evidence of learning to inform future planning;
- sensitive and positive feedback to pupils;
- individual target setting: SMART (specific, measurable, attainable, relevant and given in time);
- pupils understanding how well they are doing and how they can improve.

### **Effective Ethos and Classroom Environment**

Each of our teachers makes a special effort to establish good working relationships with all pupils in the class. We treat the pupils with kindness and respect. We recognise that they are all individuals with different needs, but we treat them fairly and give them equal opportunity to take part in class activities. All our teachers follow the school policy with regard to discipline and classroom management. We set and agree with pupils the class code of conduct. We expect all pupils to comply with these rules that we jointly devise to promote the best learning opportunities for all. We praise pupils for their efforts and, by so doing, we help to build positive attitudes towards the school and learning in general. We insist on good order and behaviour at all times. When pupils misbehave we follow the guidelines for sanctions as outlined in our school behaviour policy. We aim to provide a learning environment which:

- is challenging and stimulating;
- is peaceful and calm;
- is happy and caring;
- is organised and well-resourced;
- makes learning accessible;
- is encouraging and appreciative;
- is welcoming;
- provides equal access and inclusion;
- provides a professional working atmosphere.

## **Enrichment opportunities**

All pupils have the opportunity to develop existing interests and nurture new ones through a variety of clubs and enrichment activities, which operate during and after school. These reflect the talents and interests of the staff and pupils. The extra-curricular clubs range from Makaton and hand bells to role playing games and tag rugby. Children have the opportunity to learn gardening skills, animal husbandry and appreciation of nature as well as a variety of musical instruments and artistic pursuits. From Prep 1, children are able to join the School Beavers group, which meets in the school each week and conducts a wide range of activities from fencing to survival skills, as well as regular hikes and visits from outside speakers.

## **The Quality of Teaching**

The Head of Academic Studies carries out book appraisals, whereby books are checked for quality of feedback, consistency of marking and being up to date. Planning appraisals are carried out by the Head of Academic Studies who checks planning is up to date and evaluated. All teachers are observed working with classes once or twice a year, and Newly Qualified Teachers (NQTs) are observed each half term by the Deputy Head Teacher. The criteria that we use have been agreed by all teachers, and are part of our teaching and learning policy. The teacher and the observer follow the observation with a discussion. The observer notes the strengths and areas for development, and gives a copy of this information to the teacher. She uses the information gained from this monitoring process to help identify common development points which can be addressed in the school's training programme for continuing professional development. The purpose of the teaching at Orchard School:

- enables pupils to acquire new knowledge and make progress according to their ability so that they increase their understanding and develop their skills in the subjects taught;
- fosters in pupils the application of intellectual, physical or creative effort, interest in their work, and the ability to think and learn for themselves;
- involves well planned lessons and effective teaching methods, activities and management of class time;
- shows a good understanding of the aptitudes, needs and prior attainments of the pupils, and ensures that these are taken into account in the planning of lessons;
- demonstrates appropriate knowledge and understanding of the subject-matter being taught;
- utilises effectively classroom resources of an adequate quality, quantity and range;
- demonstrates that a framework is in place to assess pupils' work regularly and thoroughly and use information from that assessment to plan teaching so that pupils can progress;
- utilises effective strategies for managing behaviour and encouraging pupils to act responsibly.

## **Assessment (see our Assessment Policy)**

At Orchard School we have an effective framework in place to assess pupils' work both regularly and thoroughly. We use the information gathered through our range of assessment methods (both summative and formative) along with Granada Learning (GL) which provides what was previous known as National Foundation for Educational Research (NFER) Cognitive ability tests, including CAT cognitive assessment tests. Pira tests are used at the end of each term to assess reading. A range of unit assessments in Maths and Science are also used to inform our planning and in modifying our teaching so that pupils can make progress. We also have a framework for evaluative pupil performance through the use of the summative assessments mentioned above.

We also ensure that our framework for pupil performance is evaluated, by reference either to both our own school aims as provided to parents and, where appropriate, the assessments taken.

## **Organisation and planning**

We plan our curriculum in three phases. We agree these plans over each key stage. This indicates what topics are to be taught in each term, and to which groups of children. Our three phases are split as follows:

Our long-term plans give an annual overview of what content of the curriculum will be taught with teachers extracting from the appropriate year group's curriculum that which they aim to cover. The Deputy is responsible for ensuring that long term and medium term plans are in place and enable pupils' skills, knowledge and

understanding to develop progressively. Assessment strategies are built in. All staff follow an agreed marking policy. Teachers plan individual lessons and include the learning intention and success criteria.

Through our medium-term plans we give clear guidance on the objectives and teaching strategies for each topic. As we have adapted the national Primary Strategy, the 2014 National Curriculum, along with the literacy and numeracy strategies by modifying the Hamilton Trust plans for our school.. We cover the objectives from the 2014 National Curriculum by modifying the Hamilton Trust plans for our school.

Our short-term plans are those that our teachers write on a weekly or daily basis. We use these to set out the learning intentions for each lesson, to plan the learning activities in which pupils will be engaged, to make clear how learning may need to be differentiated for groups of different abilities or learner types, to plan assessment opportunities and to identify what support and resources will be needed by the pupils.

Key stage 1 and Key stage 2 have adopted the Hamilton Trust plans, which the teachers adapt for their own classes. The plans are used for literacy, numeracy, science and topic. From September 2009 individual foundation subjects have been replaced by a thematic approach. To maintain coverage the Hamilton site is used as an online resource to enable the Deputy Head to track progress throughout the year. Over the three terms of the academic year, each child has the opportunity to experience the full range of National Curriculum subjects. For example, a child may concentrate in one term on a history topic, then switch to a greater emphasis on geography in the next term. Over the three terms of the academic year, each child has the opportunity to experience the full range of National Curriculum subjects. In our curriculum planning we highlight these areas, so that the pupil's progress can be identified and monitored. All subject areas contribute to a child's progress in these skills. Our school believes that all pupils need to make good progress in these skill areas in order to develop to their true potential. In the Early Years Foundation Stage (EYFS), planning follows the structure of the national Early Learning Goals and addresses the areas of learning.

We believe that pupils learn most effectively when they are able to understand connections between different areas of their experience. We want them to acquire transferable skills which can be applied in any area of knowledge or understanding. Children do not see their world in discrete compartmentalised boxes, but, rather, as a whole spectrum of experience. For this reason, wherever possible, we have a 'cross-curricular' approach to learning, planning topics or themes which will embrace a range of National Curriculum subjects, including the application of literacy and numeracy skills.

The aim is to ensure that subjects are linked where possible so that learning is meaningful to children. Themes can have a bias towards History, Geography, Science or indeed any subject but the year is planned to ensure coverage of all subjects. ICT is integrated throughout. However the new computing scheme of work will be taught within the topics and the coding aspect will be taught discretely. Maths and English tend to be taught as discrete subjects, usually in the mornings, but may be reinforced by Topic work.

This approach is most apparent in the EYFS and in Key Stage 1, but is also used in Key Stage 2. There are many times, however, when discrete, subject-related skills or knowledge cannot be easily addressed through such a cross-curricular approach, and separate subject-based lessons also feature in our planning, particularly in Key Stage 2. Curriculum coverage is regularly reviewed to ensure that, however the curriculum is planned and taught; pupils are receiving their entitlement to the full breadth and depth of the National Curriculum or the EYFS curriculum.

We recognise that children learn at different rates and sometimes have learning needs which come from an earlier or later curriculum stage. Some pupils in Year 1, for example, continue to follow the EYFS curriculum into Year 1. Some pupils in Year 2 may need to access the Year 3 curriculum, in order to engage in learning to meet their ability. Specialist teaching takes place throughout the school. This includes dance, music, French, philosophy, swimming and physical education.

### **The Early Years Foundation Stage (See also Appendix A: EYFS - Curriculum, Teaching and Learning Policy)**

The curriculum that we teach in the Prep R meets the requirements set out in the EYFS curriculum. Our curriculum planning focuses on the Early Learning Goals, as set out in these documents, and on developing children's skills and experiences.

The Foundation Stage curriculum is organised into seven areas of learning:

- Communication and Language
- Personal, Social and Emotional Development
- Physical Development
- Literacy
- Mathematics
- Understanding the World
- Expressive Arts and Design

We believe learning is holistic and none of the mentioned areas of learning can be delivered in isolation from the others. All areas are delivered through a balance of adult-led and child-initiated activities. One experience may provide children with opportunities to develop a range of competencies, skills and concepts across several areas of learning. Each area of learning works towards a number of relevant Early Learning Goals, which most children are expected to achieve by the end of the Foundation Stage. Our school fully supports the principle that young children learn through play, and by engaging in well planned and structured activities. Teaching in the EYFS builds on the experiences of the children in their pre-school learning. Each term in the reception class, the teacher will assess the skills development of each child, and record this in the EYFS Profile. This assessment forms an important part of the future curriculum planning for each child.

#### **Time allocation**

- The timetable is constantly under review and is subject to changes in staff and in staff responsibility. The aims of our timetabling policy are to ensure that every pupil has access to all areas of the timetable.
- The time allocation for computing is incorporated into the planning for other areas of the curriculum where appropriate.

#### **Spiritual, Moral, Social and Cultural Development (SMSC)**

In our school we plan and provide effectively in order to develop pupils' spiritual, moral, social and cultural awareness. Pupils of all faiths and belief systems are encouraged to strive for academic excellence and a spirit of open and shared enquiry, whilst developing their individual potential and qualities of character so they can make a positive contribution to the world. Whilst SMSC is integral to all aspects of our curriculum, PSHEE and religious education make a strong contribution. Pupils are guided towards distinguishing right from wrong, to respect the law and towards acting consistently with their beliefs and with a view to the consequences of their own and others' actions. In addition our school:

- Leads pupils towards becoming confident and positive contributors to their community and effective users of its services and facilities according to their maturity;
- Enables pupils to gain insights into the origins and practices of their own cultures and into those of the school and wider community;
- Takes steps to ensure that the pupils appreciate racial and cultural diversity and avoid and resist racism;
- Ensures that pupils are able to understand and respond to risk, for example risks associated with extremism, new technology, substance misuse, knives and gangs, personal relationships and personal safety;
- Enable pupils to develop their self-knowledge, self-esteem, self-confidence and sense of personal agency;
- Encourage pupils to accept responsibility for their behaviour, show initiative and understand how they can contribute to community life;
- Provides pupils with a broad general knowledge of public institutions and services in England;
- Assists pupils to acquire an appreciation of and respect for their own and other cultures in a way that promotes tolerance and harmony between different cultural traditions;
- Encourages pupils to respect the fundamental British values of democracy, the rule of law, individual liberty and mutual respect and tolerance of those with different faiths and beliefs;
- Precludes the promotion of partisan political views in the teaching of any subject in the school.

We also take such steps as are reasonably practicable to ensure that if political issues are brought to attention of pupils:

- while they are in attendance at the school;
  - while they are taking part in extra-curricular activities which are provided or organised by or on behalf of the school; or
  - in the promotion at the school, including through the distribution of promotional material, of extra-curricular activities taking place at the school or elsewhere;
- they are offered a balanced presentation of opposing views.

### **Personal, Social, Health, Economic Education (PSHEE) and Citizenship**

Orchard School is committed to providing a comprehensive programme of PSHEE for all its pupils, which is appropriate to their age and needs. Responsibility for developing and implementing this programme rests with the Headmistress. Each child's PSHEE and Citizenship education informs all aspects of the school day. The form this takes ranges from the way we treat each other to planning food technology lessons based on individual's cultural heritage. We have a cross-curricular approach to PSHEE, and its associated objectives may be addressed in Topic, Circle Time, Drama, Philosophy, Assemblies or other curriculum areas. Our structured play sessions are specifically tailored to the needs of the group, from working with a child coping with parallel play to facilitating turn taking and initiation. We 'help pupils achieve more' by ensuring that all pupils are given the opportunity to be healthy, stay safe, enjoy and achieve, make a positive contribution and achieve economic well-being.

We provide positive experiences through planned and coherent opportunities in the curriculum, extra-curricular activities and through interactions with teachers and other adults for our pupils. Our range of artistic, sporting and other cultural opportunities is available to pupils through the curricular and extra-curricular programme, and their participation in these opportunities. We plan our personal, social and health education and citizenship through assemblies, Philosophy and 'circle time' to help our pupils acquire values and skills to enable them to develop independence and choose their path in life. Orchard School seeks to:

- develop an ethos and environment which encourages a healthy lifestyle for pupils;
- use the full capacity and flexibility of the curriculum to help pupils to achieve safe and healthy lifestyles;
- ensure that food and drink available across the school day reinforces the healthy lifestyle message;
- provide high quality Physical Education, with specialised teachers, and sport to promote physical activity;
- promote an understanding of the full range of issues and behaviours which impact upon a lifelong health and well-being.

We aim for our pupils to understand and appreciate the range of different cultures and faiths in modern democratic Britain. We use our schemes of work and other plans which enable pupils to develop an understanding of public services and institutions and to take their place in modern democratic British society. We provide a range of quality opportunities for pupils to take on responsibility in school and make a positive contribution to the school, local and wider communities.

### **The Deputy Head**

Orchard School wishes to involve all staff in planning and developing all areas of the curriculum. In their area, they must:

- provide a strategic lead and direction;
- support and offer advice to colleagues;
- monitor child progress in their subject area;
- provide efficient resource management;
- arrange school based training, or team teaching, if needed;
- attendance at local conferences and courses, if appropriate;
- dissemination from courses/action research/newsletters, where appropriate;
- provide articles for the school newspaper and website;
- ensure Orchard School forum is kept up to date;
- commit to personal professional development in the area of responsibility;

Each teacher reviews the curriculum plans for their year ensuring that progression is planned into schemes of work. The Blue Assessment folders, which are used to show the achievement of pupils at each key stage and to give examples of expectation of attainment, are kept for each year.

### **Director of Academic Studies**

- reviewing planning: meeting NC Programmes of Study where applicable;
- learning scrutiny: consider standards across all abilities and ages (with colleagues);
- resourcing: ensure resources are appropriate/suitable stored/labelled etc;
- identify shortfalls in resources: gaps in provision, ensuring resources in school are used;
- evaluate value for money when resources are purchased and deployed;
- informal monitoring during year – displays, use of resources, photographs, pupil interviews and feedback
- review and update Scheme of Work for the subject, if necessary;
- attendance at local conferences and courses, if appropriate;
- dissemination from courses/action research/newsletters, where appropriate;
- provide articles for the school newspaper and website;
- annually evaluate schemes of work and programmes of study.
- commit to personal professional development in the area of responsibility;

### **Pupils with Special Educational Needs and Disabilities (SEND)**

The curriculum in our school is designed to be accessed by all children who attend the school. If we think it necessary to modify some children's access to the curriculum, in order to meet their needs, then we do this only after their parents have been consulted. If a child has a special need, our school complies with all legislative and best practice requirements to meet these individual needs. If a child displays signs of having special needs, then his/her teacher makes an assessment of this need. In most instances, the teacher is able to provide the resources and educational opportunities that meet the child's needs, within normal class organisation. If a child's need is more severe, we consider the child for a statement of special educational needs, and we involve the appropriate external agencies in making an assessment. We always provide additional resources and support for children with identified special needs.

Our curriculum is well planned for each age group and key stage and ensures that pupils of all abilities, including those with special educational needs and/or disabilities are able to acquire knowledge and understanding, develop and practise new skills, and make progress in a range of areas of learning. We design our curriculum to ensure that it is broad, well balanced and covers all the required areas of learning. We modify our curriculum and teaching to meet the needs of individuals and groups of pupils including our gifted and talented and disabled pupils or those with a special educational need. If children in our school have disabilities then we are committed to meeting the needs of these children. All reasonable steps are taken to try to ensure that disabled children are not placed at a disadvantage compared with non-disabled children. Teaching and learning are appropriately modified for children with disabilities.

This includes providing an individual learning programme (IEP) which is reviewed on a regular basis. The provision in this respect is coordinated by the SENCO. This sets out the nature of the special need, and outlines how the school will aim to address it. The IEP also sets out targets for improvement, so that we can review and monitor the progress of each child at regular intervals. Where a pupil has a statement, the SENCO liaises with the child's teachers to ensure that the education the pupil receives fulfils the requirements of the Statement along with enabling the pupil to participate fully in the annual review for the Local Authority. Should a pupil be in receipt of a statement of special educational needs, we will endeavour to give them an education which meets their needs as specified by their statement. We ensure that our admissions, discipline and other procedures take account of pupils' additional needs. It is likely that some pupils in possession of a statement cannot be accommodated at Orchard School due

to their needs being beyond the resources available, requiring greater readjustment than is possible. Where possible, this will form part of discussions during the admissions process.

### **English as an Additional Language (EAL)**

We are committed to providing pupils with the necessary support and teaching who require English as an additional language. Where this is required an appropriate programme will be implemented.

### **Expectations of Staff**

Staff are expected to actively promote the curriculum aims by:-

- having high expectation of pupils;
- employing a variety of learning and teaching methods;
- having appropriate knowledge and understanding of the subject matter being taught;
- ensuring that pupils are enabled to access the curriculum and given opportunities to be successful;
- having a good understanding of the aptitude, needs and prior attainments, of the pupils and ensuring that these are taken into account in the planning of these lessons;
- delivering lessons which build upon previous experience, providing continuity and progression;
- providing learning opportunities which offer depth and challenge and motivate and inspire pupils;
- utilising effective classroom resources of a high quality, quantity and range appropriate to the learners' needs;
- involving pupils in the process of learning, by discussing work, giving regular formative feedback through discussion, assessment and marking, negotiating targets and encouraging pupils to evaluate their personal achievements;
- developing pupils' skills to become independent learners;
- encouraging, rewarding and valuing achievement and effort, both formally and informally, through praise in the learning environment;
- working in partnership with pupils, staff and parents to achieve shared goals;
- keeping parents/carers regularly and fully informed about the progress and achievements of their pupils through reports and parents' evenings.

In our school the most important role of teaching is to promote learning in order to raise pupils' achievement. For us, teaching includes lesson planning, the implementation of plans, as well as marking, assessment and feedback. It also includes support and intervention strategies. In assessing the quality of the teaching in our school we take account of the evidence of pupils' learning, achievements and progress over time. When evaluating the quality of teaching in our school, we consider how successful the teaching is in promoting the learning, progress and personal development for every pupil by:

- extending the previous knowledge, skills and understanding of all pupils in a range of lessons and activities over time;
- enabling pupils to develop skills in reading, writing, communication and mathematics ;
- enthusing, engaging and motivating pupils to learn;
- using assessment and feedback to support learning and to help pupils know how to improve their work;
- differentiating teaching, by setting suitably challenging activities and providing support for pupils of different abilities, including the most able and disabled pupils and those who have special educational needs, so that they can all learn well and make progress;
- enabling pupils to apply intellectual, physical or creative efforts and develop the skills to learn for themselves and setting high expectations;
- setting appropriate homework;
- using well-judged and effective planning and teaching methods, deploying appropriate resources, managing class time and other adults in the classroom and drawing on good subject knowledge and expertise to enable pupils to make good progress;
- using effective strategies for managing behaviour and encouraging pupils to act responsibly.

We use lesson observations by colleagues and teacher self-evaluation which takes account of:

- how well challenging tasks are matched to pupils' learning needs and successfully engage all pupils in their learning;
- how well pupils understand how to improve their learning as a result of frequent, detailed and accurate feedback from teachers following assessment of their learning;
- pupils' attitudes to learning, behaviour and relationships in the classroom;
- the promotion of pupils' spiritual, moral, social and cultural development.

### **Disapplication**

In accordance with the law Orchard School has the right to respond to individual needs by modifying the curriculum programmes. It will allow a pupil to participate in extended work-related learning, allow a pupil with individual strengths to emphasise a particular curriculum area, allow a pupil making significantly less progress than other pupils of his/her age to consolidate his/her learning and progress across the curriculum. Decisions will only be made after discussion with the parents.

### **Religious education**

Religious Education is incorporated into distinct lessons available to all pupils. We also celebrate Christianity during our assemblies. Other religions are also taught, so pupils have a broader understanding of the diverse world that they are living in.

### **Sex and Relationships Education**

The School provides Sex and Relationships education in the basic curriculum in which pupils are encouraged and guided by moral principles and taught to recognise the value of family life. It forms a key part of the Personal, Social and Health Education (PSHE) course and has regard for the government's guidance in Sex and Relationship Education Guidance (0116/2000). See Jigsaw course

### **Cultural education and appreciation of diversity**

Orchard School includes aspects of cultural education in many specific and cross-curricular ways. All pupils are encouraged to develop an awareness of equality of opportunity.

### **Political education**

The promotion of partisan political views in the teaching of any subject in Orchard School is forbidden by law. Political issues are introduced through current affairs, and are presented in a balanced manner.

### **PE and Swimming**

All pupils are expected to take part in the school's Physical Education programme. Pupils can only be excused from PE and Swimming lessons for medical reasons, for which a note from a parent will suffice, or other reasons agreed with the school.

### **Extra-curricular activities**

Orchard School has an extensive programme of activities that take place outside the formal curriculum.

### **Learning outside the classroom - educational visits/off-site activities**

Integral to our curriculum is a wide range of educational experiences that extend beyond the classroom door. Orchard School curriculum offers a series of educational journeys that deepen the pupils' understanding of the world around them. Trips extend pupils' knowledge of past and present. In Key Stage Two, pupils have the opportunity to go on residential trips. Our experience is that pupils forge strong bonds of friendship during the trips, and their respect for one another grows as a result of sharing the experiences.

### **Homework**

Homework is given to pupils at different stages of their development. We recognise the importance and value of homework as an extension and consolidation of classwork. Teachers ensure that an appropriate level and standard of homework is regularly set and marked so that learning outcomes may be consolidated and the needs of individual pupils identified and met. We have a separate Homework Policy and parents receive a homework timetable.

Homework assignments can be varied in line with the competency of the pupil. However, scope for this is limited by the nature of the courses in which outcomes are similar for all members of a class. For details of our homework procedures, please see our 'Homework Policy'.

### **Transition Support**

We ensure all pupils are prepared for their transition into the next academic year and Key Stage. We have a transition morning each end of year, where pupils spend the morning with their new teacher. At the beginning of the school year we host a 'Meet the Teacher' evening where parents are introduced to their new classrooms. During the summer term, prior to reception children joining the school, the reception teacher will spend time in the nursery class and the parents have an opportunity to meet with the teacher during a 'Housekeeping' session after school.

### **Academic Excellence and Entrance Examinations**

Whilst accepting the need to prepare its pupils for their next School education, we also strive to ensure that the pursuit of these goals is consistent with achieving the other goals set out in this policy.

### **Communication with Parents and Guardians**

We believe that parents and guardians have a fundamental role to play in helping pupils to learn. We do all that we can to inform parents and guardians about what and how their pupils are learning by:

- holding parents' evenings to explain our school strategies;
- holding an informal parents' evening at the beginning of the Autumn term 'Meet the Teacher' and a formal parents' evening in the end of the Autumn term and Spring term.
- sending information to parents and guardians, through diaries, emails, Orchard School Forum etc.
- Informing parents through a topic web what they will be studying that term and what resources will be needed
- meeting regularly with parents and guardians in which we explain the progress made by each child and indicate how the child can improve further ,e.g. target setting;
- explaining to parents and guardians how they can support their pupils with homework. We suggest support for older pupils with their projects and investigative work;
- being available - we have an open-door policy.

We believe that parents and guardians have the responsibility to support their pupils and the school in implementing school policies. We would like parents and guardians to adhere to the Parent School Contract (Terms and Conditions). These include:

- ensure that their child has the best attendance and punctuality record possible;
- do their best to keep their child healthy and fit to attend school;
- inform the school if there are matters outside of school that are likely to affect a child's performance or behaviour at school;
- promote a positive attitude towards school, staff and learning in general;

ensure homework is completed to the best of the child's ability.
